NARRATIVE

On Sunday, June 10, 2024, at approximately 11:26 PM, while on uniform marked patrol within the City of Fort Myers, FL, Officer Yolhen Hernandez was dispatched to [redacted], Fort Myers, FL, in regard to a contact person. The incident location was later determined to be at 2948 Grand Avenue.

Upon arrival, contact was made with the complainant, [redacted] only spoke Haitian Creole, therefore, she had [redacted] translate, as the following was learned:

[redacted] were within the above referenced location asleep in their bedroom. [redacted] suddenly heard someone within the residence screaming "Help! He is killing me!", multiple times. At this point, Officer Hernandez requested a creole-speaking officer to respond.

Once Officer Saint Jean arrived on scene, through further investigation it was learned that [redacted] was originally within the residence along with [redacted], Willy Lumaine (Black/Male, Date of Birth: January 19, 1991) and their roommate, [redacted] Willy had been mad since yesterday on June 8, for unknown reasons. Willy continued to be mad all day long throughout June 9, until he eventually said he was going to leave the residence because it was too hot. [redacted] believed there was no issue with that, therefore, she went to sleep [redacted]. As [redacted] slept, she overheard someone screaming "Help! He is killing me!" multiple times. In fear, [redacted] grabbed [redacted] and immediately ran away from the residence until she reached [redacted], where the residents helped her and called police.

Officer Saint Jean was able to confirm the location of the residence as 2948 Grand Avenue, as the information was provided to responding units, and they began to divert to that location. Upon arrival, officers located an open front door, with a blood trail immediately visible. Officers immediately began to set a perimeter around the residence giving verbal announcements, and as they approached the rear of the residence, a black male, later identified as Willy, was seen approaching the window with a large knife in hand.

Within seconds of getting a visual on Willy, he broke the window closest to Officer [redacted] while holding a partial bloody torso of an unknown person. Officer [redacted], as officers are now giving verbal commands for Willy to drop the knife. Willy continued to slash with the knife to break the window until he was able to exit through the window and coming outside. Officers continued to give loud verbal commands in an effort to have Willy stop, and eventually utilized their department issued tasers in an attempt to stop his movements and resistance. The taser probes had no effect as Willy continued to approach officers and slash at them, until they ultimately discharged their firearms, striking Willy as he fell to the ground. The knife was secured as officers began to render aid to Willy.

While officers rendered aid to Willy, the residence was cleared to ensure the safety of anyone possible within the residence, as the remainder of the body was located within the residence, spread throughout the residence, while the head and torso were located near a

trash can outside of the residence. The identity of the decedent located within the residence is unknown at this time. The location of [REDACTED] is unknown at this time as well.

Sergeants Moussa, Cutie, and Maldonado responded to the scene along with Detectives Langton and Louissaint. The Fort Myers Police Department's Crime Scene Unit along with the Florida Department of Law Enforcement responded to the scene. A more detailed statement was collected from [REDACTED] by the detective division.

The above information was a synopsis of the incident. The entire interaction was captured on officer's department issued body-worn camera's.
